## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Skin contact:** If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

**BRAKE PAD:** Collect and seal in properly labelled containers or drums for disposal.

**DUST:** Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of dust. Wipe up dust with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

### LARGE SPILLS

**BRAKE PAD:** Collect and seal in properly labelled containers or drums for disposal.

**DUST:** Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

If contamination of sewers or waterways has occurred advise local emergency services.

## 7. HANDLING AND STORAGE

**Handling:** Avoid skin and eye contact and inhalation of dust.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.
